9th NATIONAL ADVISORY COMMITTEE MEETING

Aide Memoire

The 9th National Advisory Committee (NAC) of LGCDP II was held on 25th May 2017 under the chairpersonship of Mr. Dinesh Kumar Thapaliya, Secretary, Ministry of Federal Affairs Local Development (MoFALD) and NAC chair. H.E Mr. Jorg Frieden, Ambassador, Embassy of Switzerland, DP chair, Ms. Gail Marzetti, Head of DFID Nepal, DP Co-chair, head of the mission, UN agencies, Joint Secretaries and representatives from line ministries and development partner were present in the meeting. Similarly, Under Secretaries and other staff from Ministry and LGCDP were also present in the meeting. The meeting discussed on the extension of LGCDP-II - Transition to Sub National Governance Programme, Annual Strategic Implementation Plan (ASIP) 2017/18, components and activities of transition to Sub National Governance Program followed by plenary discussions and endorsement of decisions.

Opening remarks by Mr. Dinesh Kumar Thapaliya, Secretary MoFALD and NAC chair.

Mr. Dinesh Kumar Thapaliya, Secretary welcomed distinguished participants and mentioned that meeting was organized to discuss and share on Transition to Sub National Governance Programme which is an extension of Local Governance and Community Development Programme II to support in restructuring of sub national governments, institutionalize best practices of earlier programmes, policy evolving process and knowledge management for smooth federalization.

Mr. Thapaliya, mentioned that local governments can exercise executive, legislative and judicial power in line with the Constitution and informed that Government of Nepal has approved functional unbundling report which provides strong basis to initiate devolution of functions, functionaries and fund to local governments. The GoN will transfer substantial financial resources to local governments as per the spirit of Constitution, however the challenge is to operationalize and institutionalize the rights and functions of local governments with by establishing transparent upward and downward accountable system. He raised concern on institutionalizing devolved functions and establishing a robust system that can deliver services and achieve results at local level. He noted that to strengthen accountability system MoFALD would establish performance contract mechanism between local leaders and sectorial functions. NPC, MoF, MoFALD, and MoGA are planning to develop a document jointly that will clarify the resources flow, personnel management and other aspects.

Mr. Thapaliya, expressed happiness on participation of people in the first phase of local election and political devolution. Political devolution has brought big expectation with the newly elected representative. Hence, the challenge for local government is to confront on meeting the expectations of local people and addressing capacity gaps. Local governments are responsible for cross-cutting issues like CFLG, EFLG, GESI and localizing SDG and scenarios shows there is lot of hand holding at local government level and thus there is a need of Development Partners support towards strengthening the cross-cutting agenda at local level

Mr. Thapaliya pointed out that LGCDP-II is successfully completing 4 years in the field of social mobilization, downward accountability, capacity building and public finance management fulfilling the vacuum where there was no elected representative in local bodies. He noted that the programme has managed to achieve great strides and equally overwhelmed with number of Dalits women and marginalized representative elected to public office.

Similarly, Secretary highlighted the Extension of LGCDP II - Transition to Sub-National Governance Programme has been designed with three major components: support to implement federalism: Institutional support to sub-national governments; capacity development of Sub-national governments; ICT in sub-national governments and public Financial Management support with total budget of US\$ 18.1 million for the next fiscal year. Likewise, he also mentioned continuity of present social mobilization up to 4 months and provision of funds for social mobilization on demand by rural municipalities.

Finally, on behalf of the Government of Nepal, the chair expressed gratitude and welcomed development partners for their coordinated support to build a stronger and democratic Nepal, which will ensure no one left behind.

Opening Remarks by H.E. Jorg Freiden, Ambassador, Embassy of Switzerland in Nepal, DP - Chair.

H.E Mr. Jorg Freiden, congratulated MoFALD for conducting the extraordinary NAC meeting. He expressed his enthusiasm on Nepal conducting local election peacefully. He highlighted that the LGCDP program innovation such as social mobilization would be extremely useful in the new phase.

Likewise, H.E Mr. Jorg expressed enthusiasm to work with local level representative and shared that in the changed context, transition program should respect the local autonomy of local elected representatives and support on their roles and responsibilities. In addition, he appreciated the achievement of MoFALD on social inclusion area and expressed DP's optimism to maintain social mobilization until the political institution start to work. He mentioned that DPs would commit to support on empowering the local elected representative who will take the political charges.

Moving forward, H.E. Jorg raised concern to work in the spirit of constitution in regards to social inclusion in transition phase. He further said that substantial amount will be directly transferred in local level for designing and implementation of the program. Public Financial Management should be the priority. Therefore, there is a need of government approach to address the priority as larger share is spent in local level, accountability should be checked with the sense of ability. Similarly, he raised concern on addressing the issues of financial arrears and noted that accountability should be maintained well for further support in future programme. It is therefore requested to conduct internal audit and settle all the audit arrears within next couple of months.

Finally, H.E. Jorg acknowledged the achievement of LGCDP, reiterated the commitment to support on extension of LGCDP-II -Transition to Sub-National Governance Programme in building strong local governance.

Release of Analysis Report of Minimum Conditions and Performance Measure (MCPM) in Nepal 2014/15

Mr. Dinesh Kumar Thapaliya, Secretary, MoFALD released - Analysis Report of Minimum Conditions and Performance Measure (MCPM) in Nepal 2014/15.

Overview of Extension of LGCDP-II Transition to Sub-National Governance Programme(TSNGP) by Mr. Reshmi Raj Pandey, Joint Secretary/ National Programme Director

Mr. Reshmi Raj Pandey, highlighted the major aspects of the Transition to Sub-National Governance Programme. He mentioned that duration of transition phase is 16th July 2017- 15th July 2018 and executing agency is the Ministry of Federal Affairs and Local Development (MoFALD) which will be implemented by local governments. The total budget for the program is US\$ 18.1 million of which GoN contribution is US\$ 2.1 million, DPs contribution for JFA is US\$ 13.5 million and for Technical Assistance is US\$ 2.5 million where DFID, Norway, SDC, UNICEF, UNFPA and UN Women has committed as JFA partners and DFID, Norway, UNDP, UNCDF and UNV has committed as Technical Assistance partners.

Mr. Pandey mentioned that the objective of transition programme is to support the institutionalization of Sub National Governance (SNGs) for smoother and efficient transition management and strategy is to focus on policy support and capacity building with whole of government approach and risk assessment and scenario thinking. Moving forward he highlighted that the programme management will have three committees viz. National Steering Committee, National Executive Committee and Technical Assistance Sub- Committee. Programme will be supported by the Program Co-ordination Units (PCU), Development Partners Cell (DP Cell) and seven Provincial Support units (PRSUs).

Moreover, Mr. Pandey mentioned that the TSNGP will support to implement federalism and continue social mobilization for four months. In case of public finance management, Municipal Administration and Revenue System (MARS) will be rollout in municipalities and rural municipality in phase wise. Likewise, he mentioned that TSNGP has three outcomes which are supported by five outputs which are i). SNGs institutionalized and capacity to serve their citizens as per the spirit of the constitution, ii). social mobilization sustained within new SNGs and iii). Strengthened public financial management.

Program Activities and ASIP of LGCDP-II Transition to Sub National Governance Programme(TSNGP) by Mr. Resham Lal Kandel, National Programme Manager.

Mr. Resham Lal Kandel highlighted the activities of TSNGP, ASIP 2017/18 and LGCDP I and II audit arrears and progress settlement. Following are some key activities:

Output one: Sub- national government institutionalized

Under output one, activities will be carried out to bring the sectorial agencies at sub-national level under the purview of SNGs, provide technical support for establishing LGs office. Further, it will support in

preparation of model manual and guidelines to strengthen the monitoring and supervision system in District Coordination Committees and will also support to establish communication system in sub national governments. The total budget for output one is US\$ 4.977 million.

Output two: Capacity development of sub national government

Under output two, activities will be carried out to strengthen existing regional training centers as provincial LG training centers. Further it will develop training manuals, curriculum for LG officials, train resource persons at provincial level and local level representative and provide on the job mentoring and coaching. The total budget for output two is US\$ 5.13 million.

Output three: Policy support to federal restructuring:

Under output three, activities will be carried out to prepare a white paper to take stocks on the implementation of federalism with developing transition management plan, SNGP for future years. Further it will support in drafting and preparation of model laws, regulations and will also support Office of the Prime Minister and Council of Ministers (OPMCM), Ministry of Finance (MOF) and line ministries to operationalize sectoral devolution. The total budget for output three is US\$ 0.551million.

Output four: Continuity of social mobilization and social development:

Under output four, activities will be carried out to continue social mobilization in exit modality to handover to local governments (LGs) and to sustain demand based social mobilization in rural municipalities. The total budget for output three is US\$4.480 million.

Output five: Public Financial Management (PFM) at sub national government level sustained and strengthened.

Under output five, activities will be carried out to support MARS roll out in LGs, and promotion of e-procurement system. Similarly, activities will be carried out to adapt rural municipality accounting software based on MARS modules and to orient LGs staff on risks based internal audit system. The total budget for output five is US\$ 1.00 million.

Regarding the status of programme audit arrears and progress in settlement, Mr. Kandel pointed out 20% progress in District Coordination Committee, 16% progress in Program Co-ordination Unit and 12% progress in pipeline. The cumulative expected settlement of audit arrears by the end of this fiscal year is 65%.

Plenary Discussions

NAVIN: Representative form the NAVIN congratulated programme management for comprehensive presentation on Transition to Sub National Governance Programme and expressed positivism on expected outcome of SNGP being relevant to local governance avenue. In designing Sub National Governance Program, assessment of local level needs after local administration in action would be important. In addition, adoption of Local Government Association (LGAs) role in transition phase could be considered for strengthening local governance as LGA could be agency to revise the policy in capacity building purpose.



ADDCN: Representative from the ADDCN mentioned that Local Governance and Community Development Programme's objective is to support the local governments, thus revision of support to federalism component as support to implement sub- national governance administration in federal context would be more relevant in the changed context.

UNICEF: Representative from the UNICEF mentioned that capacity building of newly elected representative would be for three days' orientation from June. Initial orientation will focus on process, plan, budget, roles and responsibility of local representative. Putting further what could be plan or idea, beyond the mechanism process on issues like education, health, gender equity and inclusion? Over the period, what kind of interaction between LGCDP and agencies will be there in regards to capacity building?

EU: Representative from EU mentioned that the total budget for the programme is US\$ 18.1 million out of which government contribution is US\$ 2.1 million, DPs contribution in JFA is US\$ 13.5 million and DPs contribution in Technical Assistance US\$2.5 million. The representative made an query to know on status of all mentioned funds being secured or programme is looking for additional fund for its management.

Norway: Representative from Norway appreciated MoFALD and the Joint Task Force for giving clarity on the LGCDP II transition phase, It is positive to see that there will be involvement of sectorial agencies and line ministries in the governance structure, and that an overall Transition Management Plan will be prepared. Fiduciary risk management is one a major concern of the program. Norway request the government to prioritize this at a high level, and provide a clearer management response and more regular and elaborate updates on the audit arrears issue. The way fiduciary risk is handled including addressing and preventing audit arrears will affect Norway's ability to disburse to the current project and support a future governance program.

FCGO: Representative from FCGP mentioned that the total audit arrears for LGCDP-I and II as of 15th July 2016 is NPR 1536 million. Would it be possible to categorize these arrears in terms amount regularized, advanced, reimbursed or recovered?

Response on Queries

Mr. Reshmi Raj Pandey mentioned that LGCDP has not forgot the role of Local Government Associations (LGA) and assured to work with Associations in future program as well. In regards to the contribution made by LGA, Mr. Pandey appreciated LGAs for playing important role at the time when there was no local level elected representative.

Regarding the fund for the transition phase management, Mr. Pandey mentioned that JFA -DPs have committed the fund in response to resource demand. However, many issues may come during the implementation of TSNGP in such a situation additional funds from DPs will be welcomed. Moreover, he mentioned that Indian Embassy in Nepal is also in communication regarding the fund to support social mobilization activities. Moving forward, Mr. Pandey noted that fiduciary risk is the major concern and MoFALD is serious on fiduciary risk reduction issues. Regarding, type of audit arrears he mentioned that NPRs 40 million is to be recovered fund (3%), NPRs 300 million is advanced (20%), NPRs 1.19 billion is to be regularized amount (77%).



Remarks by Mr. Mahendra Thapa, Joint Secretary, Ministry of Women, Children and Social Welfare.

Mr. Mahendra Thapa commended MoFALD on extending LGCDP-II transition to sub national governance phase to support local governance and appreciated that the program has incorporated many areas of local governance. Likewise, Mr. Thapa extended Ministry of Women, Children and Social interest to work with Ministry of Federal Affairs and Local Development and informed that Ministry is in the process of reorganizing the entity and administration units.

Remarks by Mr. Babu Ram Gautam, Deputy Auditor General, Office of Auditor General (OAG)

Mr. Babu Ram Gautam shared his happiness over completion of first phase of local election and mentioned that people have high expectation from elected representatives. Since the expectation is high, the major concern is on how to enhance and promote accountability and transparency in local level.

Likewise, he that OAG is mandated to carry out audit of local level as per the constitution which mentioned that the chart of account should be approved by the Auditor General. In this regard MARS rolling out need to be carried in consultation with OAG. He expressed concern on conducting internal audit and strengthening external audit within the program activity.

He suggested MoFALD to invite the representative from OAG in the orientation program for the mayors, vice mayors as it will support local level representative to understand the issues related to audit and its impact and noted that OAG is planning to open provincial level offices which will be responsible to carry out the audit at local level.

Mr. Gautam noted that LGCDP-II transition phase should learn lesson from earlier phase in terms of audit irregularities and ensure accountability. There are some issues with audit and in country program action plan of UNDP has clearly mentioned that the audit of UNDP should be led by OAG and should be supported by private sector. H reiterated that the Public Financial Statement of LGCDP should come to OAG in timely manner with complete cumulative statement for the certification statement and MoFALD should work for resolving audit arrears issue as soon as possible.

Felicitation of Ms. Gail Marzetti, Head of DFID, DP Co-chair

Mr. Reshmi Raj Pandey thanked Ms. Gail Marzetti for her continuous support as co- DP chair, her impeccable commitment and support toward strengthening local government through LGCDP-II. On behalf of MoFALD, Mr. Dinesh Kumar Thapaliya, Secretary of MoFALD, presented Ms. Marzetti with token of love.

Remarks by Ms. Vallerie Julliand, Resident Coordinator, UN.

Ms. Vallerie Julliand expressed her happiness on attending the NAC meeting for the first time. She appreciated the efforts of LGCDP for leading this platform.

She noted that local level election is the first step to enter into federal system and this is moment of victory. She congratulated Nepal for this moment. Similarly, she emphasized inclusion is not





only the provision of constitution, but also representation of Dalit people and women in the electoral process. In the same manner, inclusion is also chance for the people get to vote in local election through which there will be possibility for local people to be heard through local government. She insisted that local governance mechanism as golden opportunity to localize Sustainable Development Goal (SDG) and suggested LGCDP team, to consider SDG during the transition phase and its other elaboration as it will be plus point to achieve its outcome.

She noted that social mobilization is crucial, it is the way to bring about the changes, through the social mobilization participation of diversity and have recognized this diversity during local election. Now important is to empower this people, otherwise will make no sense even with going local election. In nutshell, the crucial point is to empower, help and give knowledge to elected representative so that they can fully play the role they have been assigned. UN acknowledge LGCDP for initiating this activity and has positivism that UN can support local governance through its diversity role and UN is honored to support for the solid diversified inclusion.

Remarks by Ms. Gail Marzetti, Head of DFID Nepal, DP Co-chair

DP Co- chair expressed thanks for the kind token of appreciation and said she is very pleased to sharing the platform on the topic of local governance.

She shared that Nepal is going through historical moment and it is very exciting as well as stressful time as local election and federal decentralization becomes reality. In approving LGCDP-II transition phase it is important for LGCDP to look back for its impact in local level. In this scenario, it is seen this year 4.3 household have benefited from more than 75000 small scale infrastructure projects and about more than 4000 social mobilizers have provided link between people and local government in past years when there was no local representative. Therefore, observing this impact, in long term LGCDP legacy will set new standards in public participation in governance and this is significant achievement for LGCDP.

In addition, the other achievement of LGCDP is to have its former members of CAC to stand up as candidate in local election and their confidence to stand for themselves. This level of empowerment in women was also seen during the time of field visit.

Similarly, looking forward to support the governance, LGCDP should not change its mindset to stand as server for the new 700 clients who will be representation local people for implementation of local governance. She noted it is important for LGCDP to be flexible as there is no clear picture on how local governance will work. At the same time, she shared that for LGCDP this is also time to develop the concept on sub national governance.

Finally, she wished for the success of LGCDP and stressed that there is plenty of room to work in the field of local governance. For its effective implementation, there is need of coordination from all the agencies.

Closing remarks by Mr. Dinesh Kumar Thapaliya, Secretary MoFALD and NAC chair.

Mr. Dinesh Kumar Thapaliya expressed gratitude and thanked distinguished participants for their valuable time and deliberations. Mr. Thapaliya assured that all suggestions and decisions delivered in the meeting will be considered positively.

He appreciated the support of all the DPs, FCGO, OAG, line ministries and stakeholders for running the LGCDP smoothly and expressed confidence for continuous support and encouragement from stakeholders for LGCDP-II — Transition to Sub National Governance Programme.

On behalf of the Government of Nepal, he thanked development partners for their continuous support in local governance and community development.

Decisions:

- 1. The NAC welcomed Mr. Dinesh Kumar Thapaliya, Secretary of MoFALD and chair of NAC and expressed confident on his guidance during the crucial period of transition. The NAC thanked to the then NAC chair and Secretary of MoFALD Mr. Kedar Bahadur Adhikari for his efforts to steer LGCDP-II smoothly and successfully and appreciated his leadership.
- 2. The NAC took note of LGCDP-II Transition to Sub- National Governance Programme document and concur with the recommendation of the Joint Task Force and the Government of Nepal decision in endorsing the programme document and recommended LGCDP-II management to formalize the necessary arrangement for LGCDP-II TSNG.
- 3. The NAC thanked the Joint Task Force, DPs effort and MoFALD for its efforts made towards financing the LGCDP-II Transition to Sub-National Governance Programme, NAC formally endorses the TSNGP programme document.
- 4. The NAC appreciated DP and LGCDP-II management for preparing the LGCDP-II Transition to Sub-National Governance Programme, Annual Strategic Implementation Plan (ASIP) 2017/18 and recommended for implementation.
- 5. The NAC recommended to broaden the Joint Task Force membership with two additional members, one from OPMCM and one from MoGA as the Sub- National Governance Programme will take the whole government approach.
- 6. The NAC recommended the extension of the current Joint Task Force until December 2017 with additional mandate to oversee the preparation of Sub National Governance Programme to be presented in November 2017 NAC meeting.
- 7. The NAC recommended MoFALD to establish a mechanism to coordinate with all DPs who are interested in supporting various capacity development activities planned for newly elected represents and official of LGs in coherent and concerted manner.

- 8. The NAC placed on record to its sincere appreciations to DPs who have made a financial contribution toward supporting the TSNGP.
- NAC recommended MoFALD to resolve all the audit arrears/Issues and prepare detailed audit report addressing all the audit issues raised by OAGN audit report until this fiscal year and settle the issues with all DPs by the end of the next fiscal year (2074/75).
- 10. The NAC expressed its deep appreciation to Dr. Gail Marzetti, Head of DFID Nepal for her impeccable commitment and support toward strengthening local government local government through LGCDP-II, the committee expressed best wishes in her future endeavors as she is successfully completing her tenure and leaving Nepal.
